LOF Round-Up 2020 to 2021

We are pleased to provide our annual LOF Supplement which provides details of the Lloyd's Open From Salvage Contracts contracted throughout 2020. The list relates to casualties which took place in 2020 or where the contract was signed during 2020 and includes a summary schedule on the last page.

The supplement has been compiled from information provided by Lloyd's Salvage Arbitration Branch as well as information from many salvage companies. We would like to express our thanks to all for their assistance and cooperation. It has been an incredibly difficult year as we all try to cope with the impact of the Covid-19 pandemic on our lives and at a time when the salvage industry was already facing challenges, Covid-19 has no doubt impacted and will continue to impact the sector for some time to come. In an industry where emergency response is key, salvors have had to address how they can continue to provide the type of response which we demand whilst dealing with the potential risks to their personnel and issues regarding travel and deployment of craft and equipment and possible delays with the completion of the operations. Many salvors were guick to respond to the challenges, establishing Covid-19 management teams, implementing clear rules and protocols for their staff and subcontractors to ensure they were able to demonstrate a commitment to safe working practices when asked to assist

Our Newsletter has been fuller than ever this year with many editions extending to three pages and there is no doubt 2020 has been a busy claims year for insurers. The question is whether this has translated into an increase in salvage services being performed using the Lloyd's Open Form salvage contract? The quick answer is yes and we provide details and analysis below.

As it currently stands there have been 46 LOF salvage contracts signed during the course of 2020. The figure is up slightly from the 43 LOF contracts agreed in 2019. Whilst it is only a small increase, the contracts notably relate to commercial vessels, with only four LOF services being performed to recreational vessels with

For the most part the LOF salvage services have been contracted with companies who have been regular users of the LOF salvage contract with the Multraship BV, the SMIT group. and Tsavliris Salvage performing many of the services. Some companies have had an guiet year from an LOF perspective although they may well have performed more commercial contracts carrier in the 2020 round-up. Containerships were involved in which are not reported and there has also been the withdrawal of Ardent from the market. It still remains to be seen if some of these companies will be able to survive this extremely challenging period.

Analysis of the figures for 2020 shows that in terms of vessel type bulk carriers are at the top with 16 of the LOF contracts, compared to a mere five in 2019. Of those 16 LOF salvage contracts the salvage services were for the most part performed to vessels carrying cargo with only three of the bulk carriers being in ballast. General cargo vessels topped the vessel category in the 2019 figures but they share second place in 2020 with tankers. each with eight, and of those three tankers and one general cargo vessel were in ballast. There was also an LOF to a tank barge carrving vinvl chloride.

Of course cases involving loaded tankers always raise the stakes because of the potential for the serious environmental impact which their cargoes might pose. Loaded tankers used to historically have much of the focus from an environmental perspective but we all know that even bulk carriers in ballast pose a significant threat from their fuel oil and that was demonstrated in July of 2020 when the Wakashio ran aground off the coast of Mauritius. Bad weather hampered the salvage operation and the vessel split in two, spilling her bunkers into the sea. The vessel's owners have since confirmed that the crew altered course closer to the Island in order to get better coverage for their mobile phones.

Groundings are notably up from 2019. In the bulk carrier category 12 of the 16 cases involved vessels running aground with only four of the services being performed to disabled vessels having suffered some form of mechanical failure and at least one of those casualties had the potential to run aground given that it was very close to the coast when the salvors rendered their assistance. remaining tanker LOFs included five mechanical failures and two

fires, with both of the fire cases likely to result in the vessels being declared as constructive total losses. Another notable fire case in 2020 was the fire on board the Hoegh Xiamen, the only vehicle only two LOFs and there were two passenger ro-ros which were assisted on LOF terms having run aground.

Almost all of the casualties have been reported in the Casualty Newsletter, albeit there are some which were unreported entirely and we have only recently received notice of. There is one matter where we are prevented from disclosing the name of the vessel although it was previously reported in the Newsletter but not identified as having been the subject of salvage services. Overall there have been 21 groundings, which is an increase of six from the 2019 figures, 18 engine breakdowns, which is up on 2019's figure of ten, a reduction in fire cases to four from seven and only two vessels suffered a loss of stability and required assistance compared to three in 2019. There is one case where we have been unable to establish the nature of the casualty.

The SCOPIC clause was invoked in only eight cases in 2020 compared to 18 case in 2019 and all but the Wakashio were loaded with cargo.

The 2020 figures show very clearly that there is still a much needed place for the LOF salvage contract. It is also hard to argue for the most part that the LOF salvage contract has been used inappropriately during 2020 with so many of the services involving grounded vessels. Again there is a clear move away from long ocean tows being performed under the LOF contract.

We leave you with one final thought this year, something which some of our readers have commented on over the past nine or so months. We rightly applaud our key workers in hospitals, schools and in the travel industry but let us not forget, when shipping is responsible for 80% of the World's trade, the difficulties which have faced many seafarers across the Globe, some of whom have been at sea for many months having been prevented from shore visits. We commend them for their service to global trade and also to the salvage teams who are available to assist them when the worst





During the evening of 4 September 2020 a line was established to the tanker and she was towed away from the coast by a Sri Lankan coast guard tug to avoid any risk that she may drift aground. The fire was confirmed as having been largely brought under control by 0530 hours on 5 September 2020 with authorities confirming it was mostly extinguished on 6 September 2020. Smit Singapore Pte Ltd were contracted under an LOF contract to provide further assistance to the vessel and a salvage team arrived at the casualty on 6 September 2020 having been dispatched from the UK and the Netherlands.
